



Dear Sir/Madam,

The Vice-Chancellor has been Pleased to grant provisional affiliation to your college to start B.Ed. Course for the session 2008-09 subject to fulfillment of the conditions mentioned below :-

1. It is mandatory for the college to abide with all the conditions of NCTE letter No.F-NRC/NCTE/RJ-1458/2008/57828-34 Date 20-08-08 and Edu. (Gr.-I) Department, Govt. of Rajasthan Letter No.- F10(6) Edu-I/2007 Date 09-09-08
2. If it is found at the time of inspection that college does not fulfill the required conditions of State Govt. and NCTE necessary action will be taken by the University.
3. As per the order No. F- NRC/NCTE/ RJ-1458/2008/57828-34 Date 20-08-08 issued by NCTE the annual intake to the B.Ed. course will be 100 seats. The Joint Director (Training) Secondary Education Rajasthan Bikaner in its letter No. शिविर-माध्य/शिप्र/सी/19531/2008-09/21 दिनांक 29.09.08 further classified the seats as follows :

For Arts faculty	50 seats
For Science faculty	30 seats
For Commerce faculty	20 seats
Total	100 seats

4. The admissions will strictly be made on the basis of merit list of eligible candidates provided by the University which conducted PTET examination.
5. To follow and observe the University Act, Statues, Ordinances, Regulations, Rules and instructions framed, amended, adopted and issued from time to time in general and specifically relating to follow curricula/course of study as prescribed by the University from time to time including scheme of examination and conduct of examinations.
6. (i) **Staff:** Appointment of permanent qualified Principal and Teaching staff on the full time basis selected by a duly constituted committee.
(ii) **Building:** Construction of sufficient building as per guidelines of the State Govt. & University provisions, playgrounds and Hostel building.
(iii) **Library:** Year-wise development of College library and provision of funds for journals and magazines be made.
(iv) **Endowment Fund:** Sufficient Endowment fund as prescribed in rules may be created.
(v) **Faculty Members:** Requisite qualified faculty members be appointed.
(vi) **Laboratory :** More equipments, chemicals, glassware, dummies, cutting machines display board etc. may be procured.
(vii) Appointment of qualified Librarian, P.T.I. and other staff be made as per University and Government rules.

(ix) प्रयोगशाला में आवश्यक उपकरण उपलब्ध कराये जावें।
(x) कक्षा आकार निर्धारित मानदण्डो अनुसार तैयार करवाया जाए।
(xi) पुस्तकालय में शिक्षा से सम्बन्धित संदर्भ पुस्तकें, शैक्षणिक शब्द-कोष एवं विश्व-कोष उपलब्ध होना चाहिए।
उक्त शर्तों की पालना एक माह में कर विश्वविद्यालय को सूचित करें।
7. No admission beyond the number of seats allotted by the University will be made. In case admission over and above the number of seats allotted are made the University will not conduct the Examinations of such Students and the entire responsibility for the same will lie with the college authorities. This should be adhered to strictly.
8. To provide the information as asked for by the University from time to time including statistics etc.
Further, the application for extension in provisional affiliation for the session 2009-10 along with requisite fee may please be sent to this office within a month time.



ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. **AND WHEREAS**, the institution **Saraswati Shikshak Prashikshan Mahavidyalaya, Behind Police Station, Sardar Shahar, Churu -331403, Rajasthan** has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.

3. **AND WHEREAS**, it has been decided to permit the institution two basic units of 50 students each subject to fulfillment of the following conditions namely.

- (i) The institution shall create additional facilities which include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adherence to staff norms as per Regulations, 2014 and inform the Regional Committees with required documents by October 31, 2015.
- (ii) The applicant Institution, for additional unit will be required to submit the required documents, such as land documents, Non-Encumbrance Certificate (NEC), Land Use Certificate (CLU) and the Building Plan (BP) in the format available on the website, to the Regional Committee in proof of having provided additional facilities, before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents, if available, otherwise it may be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committee shall arrange for verification of documents, inspection of the premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

4. **Now therefore**, in the light of the above and in terms of Section 14(3) (a)/15(3) (a) of NCTE Act, 1993 and in accordance with the Regulations, 2014, the Northern Regional Committee, NCTE hereby grants recognition to **Saraswati Shikshak Prashikshan Mahavidyalaya, Behind Police Station, Sardar Shahar, Churu -331403, Rajasthan** for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein, before 31.10.2015.

5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as

applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.


6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

7. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (a) Sanctioned programmes along with annual intake in the institution.
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
